Revision in Mid-Day Meal Charges (Effective from 1st July 2026)

Dear Parent,

Greetings from Salwan Public School Gurugram!

We would like to express our sincere appreciation for your continued trust and support towards the school's Mid-Day Meal Programme.

This is to inform you that, owing to the sustained increase in the overall cost of food preparation and allied meal services, a revision in the Mid-Day Meal charges has become necessary. The matter was reviewed in detail by the Mid-Day Meal Committee in consultation with the school management, and after careful deliberation, the revised charges have been approved with effect from **1st July 2026**.

Over the past year, there has been a steady increase in the prices of essential food ingredients and allied raw materials. Additionally, the cost of commercial cooking fuel, particularly LPG cylinders, has risen significantly. Transportation and logistics expenses have also escalated due to prevailing global supply chain disruptions and volatility in fuel prices. Further, the recent revision in minimum wages and statutory employee benefit obligations, as mandated under applicable labour laws and government notifications, has resulted in a substantial increase in manpower and operational costs associated with meal preparation and service delivery.

Despite these rising costs, every effort has been made to ensure that the increase remains minimal and reasonable. Accordingly, the revision has been restricted to **₹125 in the monthly charges** for both Montessori and Class I onwards, with a proportionate revision in the quarterly payment slabs.

This revision is essential to enable the vendor to continue maintaining the quality and standards of the Mid-Day Meal Programme, including:

- ❖ Freshly prepared, balanced, and nutritious meals on a daily basis
- ❖ High standards of hygiene, food safety, and kitchen sanitation
- ❖ Use of quality ingredients sourced from reliable suppliers
- ❖ Deployment of trained kitchen and service staff in compliance with statutory norms
- ❖ Consistent and timely meal preparation and service delivery

Revised Mid-Day Meal Charges

Classes	Monthly Charges	Quarterly Charges
Montessori Classes	₹1,500/- + GST (5%)	₹4,375/- + GST (5%)
Class I Onwards	₹1,650/- + GST (5%)	₹4,825/- + GST (5%)

Mid-Day Meal (Single Serving): ₹80/- (Inclusive of GST)

Please note the following:

- The discounted quarterly rate shall be applicable only if the full quarterly payment is made during the first month of the respective quarter. Thereafter, the standard monthly charges shall apply.
- Parents are requested to make the monthly/quarterly payment in advance, directly to the canteen vendor through the designated payment gateway, before the commencement of the respective month or quarter.
- In case of delayed payment beyond 15 days, a late fee of **₹5/- + GST per day** shall be applicable.
- Meal services may be temporarily suspended after 30 days of non-payment.

This revision has been undertaken only after due consideration and is intended solely to offset the increased cost of delivering a safe, nutritious, hygienic, and high-quality meal programme, without compromising the standards that our students deserve.
